North Augusta, SC—Memorial Services for Mrs. Helen Cole Field, 78, of West Woodlawn Avenue, North Augusta, SC, who entered into rest March 16, 2011, will be conducted Sunday afternoon at 2 o'clock in Fairview Presbyterian Church. Dr. G. Daniel McCall officiating.

A long-term resident of North Augusta, she joined the SRP influx into the area with her husband, Frank. A devoted mother and spouse, she was an active member of the community, serving as a volunteer in the many organizations that she supported, and taking a leadership role in several of them. Mrs. Field was an Honorary Life Member of the Volunteer Board of the University Hospital for over 50 years and was a current Board Member and a former President. She was a member of the Nancy Carson Library Board, Aiken County Indigent Care Commission, served as a Docent at Sacred Heart and was recognized with the 1998 North Augusta Exchange Club Golden Deeds Award. Mrs. Field had been a member of Fairview Presbyterian Church.

Mrs. Field was endlessly solicitous of her children's and grandchildren's needs, as well as those of her network of friends --- a network that never stopped growing because of her inability to be near a stranger and not engage him or her in conversation. She was a fierce supporter of causes great and small, ready to listen and eager to help --- but not to bake.

Survivors include two sons and daughters-in-law, Frank and Karen Field, Cambridge, MA and Alan Field and Michelle Lyon, Raleigh, NC; two daughters and a son-in-law, Cathy Field, Lexington, MA and Tracy Field and Mark Peters, Atlanta; a brother and sister-law, Alfred and Alice Cole, Willingboro, NJ; six grandchildren, Thomas, Henry, Rosemary (Raleigh), John, Helen and Christopher (Lexington).
